### Organized Crime and Democratic Governability

What should we make of the outsized role organized crime plays in conflict and crisis, from drug wars in Mexico to human smuggling in North Africa, from the struggle in Crimea to scandals in Kabul? How can we deal with the convergence of politics and crime in so-called 'mafia states' such as Guinea-Bissau, North Korea or, as some argue, Russia? Drawing on unpublished government documents and mafia memoirs, James Cockayne discovers the strategic logic of organized crime, hidden in a century of forgotten political--criminal collaboration in New York, Sicily and the Caribbean. He reveals states and mafias competing - and collaborating -- in a competition for governmental power. He discovers mafias influencing elections, changing constitutions, organizing domestic insurgencies and transnational terrorism, negotiating peace deals, and forming governmental joint ventures with ruling groups. And he sees mafias working with the US government to spy on American citizens, catch Nazis, try to assassinate Fidel Castro, invade and govern Sicily, and playing unappreciated roles in the Bay of Pigs fiasco and the Cuban Missile Crisis.

Organized crime—the Italian American kind—has long been a source of popular entertainment and legend. ### **History of the Mafia**

Comprehensive and objective, this study argues that organized crime in the United States results from the struggle to attain the elusive American Dream to achieve success at any cost by any means. The authors examine the social, economic, political, and cultural conditions that fostered growth of criminal groups and organizations in African American communities from the post-Civil War era to the ghettos of today.

### **Hidden Power**

The first English-language book to document the men who emerged from the gulags to become Russia's much-feared crime class: the vory v zakone Mark Galeotti is the go-to expert on organized crime in Russia, consulted by governments and police around the world. The vory--as the Russian mafia is also known--was born early in the twentieth century, largely in the Gulags and criminal camps, where they developed their unique culture. Identified by their signature tattoos, members abided by the thieves' code, a strict system that forbade all paid employment and cooperation with law enforcement and the state. Based on two decades of on-the-ground research, Galeotti's captivating study details the vory's journey to power from their early days to their adaptation to modern-day Russia's free-wheeling oligarchy and global opportunities beyond.

### **Organized Crime and American Power**

More than simply a study of the mafia, Alfredo Schulte-Bockholt's work argues that collaboration between political science and criminology is critical to understanding the real nature of organized crime and its power. Schulte-Bockholt looks at specific case studies from Asia, Latin America, and Europe as he develops a theoretical discussion—drawing on the thought of Max Horkheimer, Theodor Adorno, and Antonio Gramsci—of the intimate connections between criminal groups and elite structures. Ranging from an historical discussion of the world drug economy to an examination of the evolution of organized crime in the former Soviet Union, the book extends into a consideration of the possible future development of organized crime in the age of advanced globalization.

### **Made Men**

This book provides insight into the paradigmatic approaches evolved by CIA decades ago in Vietnam which remain operational practices today in Afghanistan, El Salvador, Iraq, Syria, Yemen and elsewhere. Valentine's research into CIA activities began when CIA Director William Colby gave him free access to interview CIA officials who had been involved in various aspects of the Phoenix program in South Vietnam. The CIA would rescind it, making every effort to impede publication of The Phoenix Program, which documented the CIA's elaborate system of population surveillance, control, entrapment, imprisonment, torture and assassination in Vietnam. While researching Phoenix, Valentine learned that the CIA allowed opium and heroin to flow from its secret bases in Laos, to generals and politicians on its payroll in South Vietnam. His investigations into this illegal activity focused on the CIA's relationship with the federal drugs agencies mandated by Congress to stop illegal drugs from entering the United States. Based on interviews with senior officials, Valentine wrote two subsequent books, *The Strength of the Wolf* and *The Strength of the Pack*, showing how the CIA infiltrated federal drug law enforcement agencies and commandeered their executive management, intelligence and foreign operations staffs in order to ensure that the flow of drugs continues unimpeded to traffickers and foreign officials in its employ. Ultimately, portions of his research materials would be archived at the National Security Archive, Texas Tech University's Vietnam Center, and John Jay College. This book includes excerpts from the above titles along with updated articles and transcripts of interviews

on a range of current topics, with a view to shedding light on the systemic dimensions of the CIA's ongoing illegal and extra-legal activities. These terrorism and drug law enforcement articles and interviews illustrate how the CIA's activities impact social and political movements abroad and in the United States. A common theme is the CIA's ability to deceive and propagandize the American public through its impenetrable government-sanctioned shield of official secrecy and plausible deniability. Though investigated by the Church Committee in 1975, CIA praxis then continues to inform CIA praxis now. Valentine tracks its steady infiltration into practices targeting the last population to be subjected to the exigencies of the American empire: the American people.

### **Organized Crime**

### **The Business of Crime**

While other cities are credited for birthing and honing the legendary crime figures who inevitably influenced and shaped their susceptible surroundings and culture, Miami is where the Mob, like many American citizens, often turned when seeking vacation, vice, or a new beginning. ### **Transnational Organized Crime**

Heroin, Organized Crime, and the Making of Modern Turkey explores the history of organized crime in Turkey and the roles which gangs and gangsters have played in the making of the Turkish state and Turkish politics. Turkey's underworld, which has been at the heart of several devastating scandals over the last several decades, is strongly tied to the country's long history of opium production and heroin trafficking. As an industry at the centre of the Ottoman Empire's long transition into the modern Turkish Republic, as important as the silk road had been in earlier centuries, the modern rise of the opium and heroin trade helped to solidify and complicate long-standing relationships between state officials and criminal syndicates. Such relationships produced not only ongoing patterns of corruption, but helped fuel and enable repeated acts of state violence. Drawing upon new archival sources from the United States and Turkey, including declassified documents from the Prime Minister's Archives of the Republic of Turkey and the Central Intelligence Agency, Heroin, Organized Crime, and the Making of Modern Turkey provides a critical window into how a handful of criminal syndicates played supporting roles in the

making of national security politics in the contemporary Turkey. The rise of the 'Turkish mafia', from its origins in the late Ottoman period to its role in the 'deep state' revealed by the so-called Susurluk and Ergenekon scandals, is a story that mirrors troubling elements in the republic's establishment and emphasizes the transnational and comparative significance of narcotics and gangs in the country's past.

### **Mafia Brotherhoods**

Since the late 1990s, marijuana grow operations have been identified by media and others as a new and dangerous criminal activity of “epidemic” proportions. With *Killer Weed*, Susan C. Boyd and Connie Carter use their analysis of fifteen years of newspaper coverage to show how consensus about the dangerous people and practices associated with marijuana cultivation was created and disseminated by numerous spokespeople including police, RCMP, and the media in Canada. The authors focus on the context of media reports in Canada to show how claims about marijuana cultivation have intensified the perception that this activity poses “significant” dangers to public safety and thus is an appropriate target for Canada’s war on drugs. Boyd and Carter carefully show how the media draw on the same spokespeople to tell the same story again and again, and how a limited number of messages has led to an expanding anti-drug campaign that uses not only police, but BC Hydro and local municipalities to crack down on drug production. Going beyond the newspapers, *Killer Weed* examines how legal, political, and civil initiatives that have emerged from the media narrative have troubling consequences for a shrinking Canadian civil society.

### **The CIA as Organized Crime**

Contrary to widespread belief, the United States has been following a broadly consistent grand strategy across presidential administrations for more than a century by using American power to create and expand the liberal international system. This liberal order is the outer perimeter of American security. Today, after the wars in Iraq and Afghanistan, some are calling for a policy of restraint or pulling back because they believe America is relatively safe and its resources are overstretched. Paul D. Miller argues that they are wrong. American security and the liberal international order need US leadership and are in jeopardy from nuclear-armed autocracies, violent non-state actors, and the failed states who harbor them. In response, the United States should not pull back but should continue to promote five pillars of American grand strategy: maintaining a favorable balance of power among the great powers, defending the U.S. homeland from attack, promoting democracy, investing in good governance abroad, and punishing rogue actors that threaten allies or the stability of the international system. Miller does however call for reprioritizing where around the globe the United States should focus its energies in the future, and he proposes common sense reforms to the US national security state so as to better manage foreign policy.

In the first section, What Is Organized Crime?, the author gives a succinct overview, then in part two identifies four major areas of criminal activity: Exploiting the Human Condition, Supplying the Illicit, Extortion and Protection and Manipulating Money. The bulk of the book focuses on crime groups by geographic or cultural origin, starting with the Sicilian Mafia and including those that operate in Britain, Russia, Japan, China, the U.S., Mexico and South America. Color and sepia-toned illustrations, ranging from photos of such recent white-collar felons as Nick Leeson and Michael Milken to mug shots of such legendary mobsters as Al Capone and grimly similar pictures of bloody victims of gangland hits, perfectly complement the incisive text. ### **Organized Crime in the United States, 1865-1941**

When gay couples become parents, they face a host of questions and issues that their straight counterparts may never have to consider. How important is it for each partner to have a biological tie to their child? How will they become parents: will they pursue surrogacy, or will they adopt? Will both partners legally be able to adopt their child? Will they have to hide their relationship to speed up the adoption process? Will one partner be the primary breadwinner? And how will their lives change, now that the presence of a child has made their relationship visible to the rest of the world? In *Gay Dads: Transitions to Adoptive Fatherhood*, Abbie E. Goldberg examines the ways in which gay fathers approach and negotiate parenthood when they adopt. Drawing on empirical data from her in-depth interviews with 70 gay men, Goldberg analyzes how gay dads interact with competing ideals of fatherhood and masculinity, alternately pioneering and accommodating heteronormative “parenthood culture.” The first study of gay men's transitions to fatherhood, this work will appeal to a wide range of readers, from those in the social sciences to social work to legal studies, as well as to gay-adoptive parent families themselves.

### **Los Zetas Inc.**

The relationship between criminal syndicates and politicians has a long history, including episodes even from the earliest years of America’s colonies. But while organized crime may not get the headlines it once did in North America, the resurgence of such criminal activity in Latin America, and in some European nations, has grabbed the public’s attention. In *Dangerous Liaisons* noted scholars describe and analyze the role of organized crime in the financing of politics in selected democracies in Latin America (Argentina, Brazil, Colombia, Costa Rica, and Mexico) and in Europe (Bulgaria and Italy). The book seeks to unravel the myths that have developed around crime in these locales, while providing facts and informing the debate on how organized crime corrupts democratic institutions, especially in relation to the funding of political parties and their activities. Among the subjects studied in detail are the role of organized crime in political finance through the lens of Argentina’s presidential campaigns of 1999 and 2007; Brazil’s elected officeholders and their role in corruption; the weakness of Colombia’s democracy; the growing role of money in Costa Rica’s politics; the destructive effects of drug money on Mexican institutions; the link between organized crime—narrowly and broadly understood—and political financing in Bulgaria; and crime and political finance in Italy. The work of the scholars corrects what volume editor Kevin Casas-Zamora calls “a glaring gap in the literature on the role of organized crime in the corruption of democratic institutions.” That is, the funding of political parties and their activities—which in these cases are mostly election campaigns. The chapters not only present the evidence but also can be regarded as a call to action. Contributors include Leonardo Curzio

### **Gangster Capitalism**

Consulting rare archival sources, Salvatore Lupo traces the web of associations, both illicit and legitimate, that have defined the Sicilian Mafia from 1860 to the present. He focuses on several crucial periods of transformation: the Italian unification of 1860 and 1861, the murder of noted politician Notarbartolo, the fascist repression of the Mafia, the Allied invasion of 1943, the social conflicts that followed each world war, and the major murders and trials of the 1980s. Lupo clarifies the Mafia's cultural codes and situates them within social groups and communities. He also refutes the notion that the Mafia has grown more ruthless in recent decades. Rather than representing a shift from "honorable" crime to immoral drug trafficking and violence, Lupo argues the terroristic activities of the modern Mafia signify a new desire for visibility and a distinct break from the state.

### **African American Organized Crime**

Organized Crime in Mexico takes a hard look at the dire implications of the pervasive and powerful criminal enterprises in northern Mexico, comparing and contrasting the present threat to past issues, including drug and human smuggling during the latter half of the twentieth century. Criminal organizations operating in Mexico and the United States threaten the economic well-being of North America as well as the democratic freedoms of our neighbor to the south. Cameron H. Holmes, an experienced organized-crime prosecutor and anti-money laundering expert, shows how this shift in criminal activity is extremely damaging to North American economies and explains that in order to halt this economic erosion, U.S. policy requires a new strategy, changes in thinking, and new and increased countermeasures. Strategically, we have light-years to travel and little time to do it. Without intervention criminal activity will strangle legitimate business, degrade the Mexican economy, and because the United States itself is so intimately affected, undermine the U.S. economy in turn. Continued prosperity in both countries depends on our joint success in controlling these criminal enterprises. Organized Crime in Mexico examines the new diversification and strategies of organized criminal groups, suggests a series of countermeasures, and places these issues in a global context. What is transpiring in Mexico is part of a larger international problem, and criminal enterprises currently pose new and consistent threats to economies around the world.

### **The Origin of Organized Crime in America**

Recent changes in the global economy and in international political alignments have greatly benefited the criminal

underworld. There is no question that modern organized crime, adroitly exploiting trends and changes in the global economy is acquiring transnational capabilities and conducting transnational operations. What has been learned about terrorism since the September 11, 2001 events confirms the ability of international criminal networks to operate across borders with relative ease. The enormous wealth generated by organized international crime has also encouraged corruption, money-laundering, and the development of all types of violence, from intimidation to terrorism. This volume examines the unfolding of transnational organized crime in different parts of the world and analyzes the major elements that will contribute to an understanding of this situation which will become more acute as the events of September 11, 2001 and subsequent ones have amply demonstrated. The problem of organized crime and terrorism must be confronted not only in social and economic contexts, but also from local, regional, cultural, religious, and international points of view. Only then can we begin to evaluate their impact on society. It is within this framework that the international authors of the different chapters consider the implications of and the possible answers to the following pressing questions: Does international organized crime constitute a threat to the national security of democratic countries? On the international scene, is this the phenomenon that has emerged to replace communism as enemy number one in the Western world and actually worldwide? With the globalization of the economy, has transnational criminal activity now become one of the new methods of accumulating wealth? Is this wealth then used to fund terrorist activities worldwide? Are certain militant factions now using criminal means to destabilize already underprivileged countries and undermine democratic principles in general, while ostensibly claiming to defend certain political or religious-based ideologies? Is the phenomenon of international crime spreading because it has its roots in specific forms of social protest, or because it offers a means of survival for those on the fringes of society, or because different mafias are increasingly penetrating the highest levels of political and economic power? Does the obvious inefficiency of the methods, policies, and strategies that are being used in the international fight against organized crime stem from a fundamental misunderstanding and incorrect appraisal of the very complexity of such situation? This volume will contribute to the growing literature on transnational organized crime and terrorism and serve as a valued source of information and analysis for policy formulation at the international level.

### **Double Crossed**

The rapid growth of organized crime in Mexico and the government's response to it have driven an unprecedented rise in violence and impelled major structural economic changes, including the recent passage of energy reform. Los Zetas Inc. asserts that these phenomena are a direct and intended result of the emergence of the brutal Zetas criminal organization in the Mexican border state of Tamaulipas. Going beyond previous studies of the group as a drug trafficking organization, Guadalupe Correa-Cabrera builds a convincing case that the Zetas and similar organizations effectively constitute transnational corporations with business practices that include the trafficking of crude oil, natural gas, and gasoline; migrant and weapons smuggling; kidnapping for ransom; and video and music piracy. Combining vivid interview

commentary with in-depth analysis of organized crime as a transnational and corporate phenomenon, Los Zetas Inc. proposes a new theoretical framework for understanding the emerging face, new structure, and economic implications of organized crime in Mexico. Correa-Cabrera delineates the Zetas establishment, structure, and forms of operation, along with the reactions to this new model of criminality by the state and other lawbreaking, foreign, and corporate actors. Arguing that the elevated level of violence between the Zetas and the Mexican state resembles a civil war, Correa-Cabrera identifies the beneficiaries of this war, including arms-producing companies, the international banking system, the US border economy, the US border security/military-industrial complex, and corporate capital, especially international oil and gas companies.

### **Organized Crime and Terrorist Networks**

Organized crime in America today is not the tough hoodlums familiar to moviegoers and TV watchers. It is more sophisticated, with many college graduates, gifted with organizational genius, all belonging to twenty-four tightly knit "families," who have corrupted legitimate business and infiltrated some of the highest levels of local, state, and federal government. Their power reaches into Congress, into the executive and judicial branches, police agencies, and labor unions, and into such business enterprises as real estate, retail stores, restaurants, hotels, linen-supply houses, and garbage-collection routes. How does organized crime operate? How dangerous is it? What are the implications for American society? How may we cope with it? In answering these questions, Cressey asserts that because organized crime provides illicit goods and services demanded by legitimate society, it has become part of legitimate society. This fascinating account reveals the parallels: the growth of specialization, "big-business practices" (pooling of capital and reinvestment of profits; fringe benefits like bail money), and government practices (negotiated settlements and peace treaties, defined territories, fair-trade agreements). For too long we have, as a society, concerned ourselves only with superficial questions about organized crime. "Theft of the Nation" focuses on to a more profound and searching level. Of course, organized crime exists. Cressey not only establishes this fact, but proceeds to explore it rigorously and with penetration. One need not agree with everything Cressey writes to conclude that no one, after the publication of "Theft of the Nation", can be knowledgeable about organized crime without having read this book.
