As poverty and unemployment deepen in contemporary South Africa, the burning question becomes, how do the poor survive? *Eating from One Pot* provides a compelling answer. They are the fulcrum on which household survival turns. This book describes how households in two different areas in KwaZulu-Natal are sites of both stability and conflict. As one of the interviewees put it: "We eat from one pot and should always help each other." Yet the stability of family networks is becoming fragile because of the enormous burden placed on them by unemployment and unequal power relations. Through careful analysis, the experiences of survival are discussed in relation to the restructuring of the country's welfare and social policies, and the extension of social grants. Mosoetsa argues that these policies shape the livelihoods that people pursue in order to survive under desperate conditions, but fail to address the root causes of poverty and inequality.

By looking at the detail of settlements in the twentieth century--from European colonial projects in Africa and expansionist efforts by the Japanese in Korea and Manchuria, to the Germans in Poland and the historical trajectories of Israel/Palestine and South Africa--and analyzing the dynamics set in motion by these settlers, the contributors to this volume establish points of comparison to offer a new framework for understanding the character and fate of twentieth-century empires.

Squatter Citizen

A Xhosa prince reluctantly leaves the University College of Fort Hare and goes back to the land of his ancestors to take his place as king of the Mpondomise. The clash of his modern ideas and the

traditional beliefs of his people mirrors the dash of the western way of life with African custom and tradition -- church-people versus traditionalists, school people versus 'red-ochre people', boarding school activities versus the inkundla or assembly at the royal place. The conclusion, that disaster can be averted only by the willingness of opposing forces to work together for mutual comprehension of the legitimate claims of tradition and modernity, gives a foretaste of the spirit that governed modern South Africa's political transformation. *Inggumbo Yeminyanya -- The Wrath of the Ancestors* -- is a classic of Xhosa literature. A C Jordan has a keen eye for detail, a delightful sense of humour and a dramatic style. Literal translations of Xhosa images, idioms and proverbs transport readers to the Tsolo district and conjure up the memorable speeches of the Mpondomise counsellors.

They organize, plan and build with no help from professionals. Drawing on their own skills, making the best use of limited resources and forming their own community organizations, they account for most new city housing. But the city, which thrives on their cheap labour, rejects them. Their houses are deemed illegal, because they do not conform to regulations and they are called 'squatters', because they cannot afford to buy sites legally. Their right to water, education and health care, even to vote, are often denied. This book challenges many common assumptions about the urban Third World - for example that urban citizens live in very large cities and that cities are growing rapidly, or that city dwellers benefit from 'urban bias' in government and aid policies. It is about the lives of the 'squatter citizens' and the problems they face in their struggle for survival.

Research in the Archival Multiverse

Information and communication technologies (ICTs) have been proven to promote economic growth, but do we know that ICTs reduce poverty? This book provides new empirical evidence on access to and use of ICTs and their effect on poor households in four East African countries: Kenya, Rwanda, Tanzania and Uganda. It addresses the questions: Do women benefit economically from using ICTs? Are the livelihoods of rural users boosted? Which ICTs are being used by low-income entrepreneurs? *ICT Pathways to Poverty Reduction* presents a conceptual framework to analyze how the dynamics of poverty change over time and to shed light on whether ICT access benefits the poor as well as the not-so-poor. The chapters contain case studies on how various forms of ICTs affect different aspects of poverty based on research in East and Southern African countries at the household level or in small and medium enterprises. Six of the chapters in this book are based on data from the PICTURE Africa study between 2007 and 2010. Two additional chapters detail country-specific studies based on findings from other research projects. Overall, the study concluded that ICTs make a difference to the livelihoods of the poor and contribute to reducing both financial and non-financial dimensions of poverty. *ICT Pathways to Poverty Reduction* is essential reading for policymakers and researchers in international development, as well as staff of development agencies working on livelihoods for the poor.
