Twenty years after Edward Channing's death in 1931, historians differed rather widely in their evaluation of his work. A British author, surveying American historiography since 1890, was quite critical of Channing's major contribution, the six-volume *History of the United States*, contending that it "won only a contemporary reputation which is not wearing well." ¹ Referring specifically to the second volume of the *History*, this writer stated his feeling that it "added little of substance to what was to be found in earlier works," and that it "was so partisan as sometimes to be quite misleading." ² Quite a different view was expressed by an American historian writing in the same year. He felt that Channing seemed "assured of a niche in the historians' Hall of Fame as one of the giants of American historiography." ³ Many of Channing's findings were new, this writer emphasized, and had been useful to other historians. He concluded that Channing's *History* "wears well twenty years after his death," and, indeed, "remains one of the major accomplishments in the field of American historical writing." ⁴ Some support is given to the latter interpretation by a poll of historians, once again dated 1952, to determine preferred works in American history published between 1920 and 1935. Channing's *History* finished eighth, following only the works of Parrington, Turner, Webb, Beard, Andrews, 5 Becker, and Phillips.

Grounds for Marriage, Book and Study Guide

Of crucial strategic importance to both the British and the Continental Army, Staten Island was, for a good part of the American Revolution, a bastion of Loyalist support. With its military and political significance, Staten Island provides rich terrain for Phillip Papas's illuminating case study of the local dimensions of the Revolutionary War. Papas traces Staten Island's political sympathies not to strong ties with Britain, but instead to local conditions that favored the status quo instead of revolutionary change. With a thriving agricultural economy, stable political

structure, and strong allegiance to the Anglican Church, on the eve of war it was in Staten Island's self-interest to throw its support behind the British, in order to maintain its favorable economic, social, and political climate. Over the course of the conflict, continual occupation and attack by invading armies deeply eroded Staten Island's natural and other resources, and these pressures, combined with general war weariness, created fissures among the residents of "that ever loyal island," with Loyalist neighbors fighting against Patriot neighbors in a civil war. Papas's thoughtful study reminds us that the Revolution was both a civil war and a war for independence—a duality that is best viewed from a local perspective.

Zabecki clearly demonstrates how the German failure to exploit the vulnerabilities in the BEF's rail system led to the failure of the first two offensives, and how inadequacies in the German rail system determined the outcome of the last three offensives. This is a window into the mind of the German General Staff of World War I, with thorough analysis of the German planning and decision making processes during the execution of battles. This is also the first study in English or in German to analyze the specifics of the aborted Operation HAGEN plan. This is also the first study of the 1918 Offensives to focus on the 'operational level of war' and on the body of military activity known as 'the operational art', rather than on the conventional tactical or strategic levels. This book will be of great interest to all students of World War I, the German Army and of strategic studies and military theory in general.

This volume is an unusually large volume that includes nearly all of the Old Testament prophets, their teachings and warnings to their people, and their prophecies of the coming of the Messiah and the latter days. It covers the period of the Bible from the end of King Solomon's reign through the end of the Old Testament, including the ministries of Jonah, Micah, Hosea, Amos, Joel, Isaiah, Jeremiah, Ezekiel, Esther, Daniel, Ezra, Haggai, Nehemiah, Zechariah, and Malachi (Elijah and Elisha were covered in Volume 8). We are taken from 826 BC to 430 BC, when the Old Testament closes. Then finally, we read of the Intertestamental Period between the ministry of Malachi and the rise of John the Baptist to open the New Testament. The German 1918 Offensives

This book represents selected papers of an international conference convened by the Department of Humanities at Qatar University, Doha, in March 2013. Its theme was "Interdisciplinarity in History: An Old Method in New World Context". Twelve out of the fifty papers presented at the conference have been thoroughly reviewed, revised and compiled in this volume. Their contributions emphasize that interdisciplinary in history has become a key term for professional historians who reject the professional identity of history based on its claimed autonomy and the distinctiveness of its research methods, and argue that this claim has seriously narrowed the intellectual horizons of the discipline in terms of both teaching and research. The chapters also stress that historical research should not be confined to political events as it was by ancient historians, but, rather, be open to other

complex issues which require thorough investigation and collaboration between history and other disciplines. In this sense, interdisciplinarity in history is a process of answering questions, solving problems, or examining topics that are too broad or multifaceted to be tackled adequately by history as a discipline on its own. Therefore, history “should not be regarded as a stationary subject,” as Robinson wrote, but as a discipline that would transcend the limitations formerly imposed upon the study of the past, and integrate with other social science disciplines to widen its methodological scope and investigate many issues that had previously ignored or marginalized.

Long thought to be Paul, the anonymous author of Hebrews exhibits points of continuity with the apostle and other New Testament writers in the letter's (or sermon's) vision of life in the light of the crucified Messiah, but one also finds distinctive perspectives in such areas as Christology, eschatology, and atonement. Gray and Peeler survey the salient historical, social, and rhetorical factors to be considered in the interpretation of this document, as well as its theological, liturgical, and cultural legacy. They invite readers to enter the world of one of the boldest Christian thinkers of the first century.

The Book of Alma. This volume is the second of three on the Book of Mormon. It covers the last chapters of Mosiah and all of the book of Alma. It begins with the story of the conversion of Alma the Younger. We learn of the beginning of the reign of the judges. Then we follow the missionary efforts of Alma and Amulek in the land of Zarahemla, followed by the missions of the sons of Mosiah to the Lamanites in the Land of Nephi. We follow the fate of the Anti-Nephi-Lehies. We read Alma's letters to his sons, including an in-depth discussion of the Great Plan of Happiness. Then we finish with the stories of Captain Moroni and Helaman's stripling warriors. In all, it covers 67 years of Nephite history from 130 to 63 BC when the book of Helaman began. We become familiar with the early lives, missions, marriages, and callings of each of these prophets, seeing how the Lord prepared them for the particular time that they led the Church. We finish with a look toward the future as we await the Second Coming of our Lord. The cover features a beautiful photograph of the Salt Lake Temple, taken at dusk during the Christmas season from the roof of the Joseph Smith Memorial Building.
